- Lori Mayfield spoke about her recent deployment with Samaritan's Purse related to the New Jersey floods to assist with rebuilding damaged homes. She was also able to able to provide crisis intervention counseling as a chaplain.
- Joey Beason discussed Samaritan's Purse and their provision of tools and materials to teams in Japan to assist with the recovery effort. He also shared Cottonwood Church's ShakeOut event.

- Annie and John Hung asked for prayers for support and safety for their upcoming mission to Taiwan to children in prisons where they share the gospel and give hope.
- Roger Tierney mentioned the OCHCA sponsored POD flu clinics planned for 10/21/11 in Anaheim, Placentia and Dana Point. First come first served.
- Charlotte & Dennis Duffy discussed Yorba Linda Friends Church's pledge for 200 schools in India and the work YLFC is doing to help other churches develop disaster response teams. They will be presenting a workshop on the topic at the Red Cross DPA on Oct. 26<sup>th</sup>.
- Bernie Koch discussed The Crossing's plan to surprise all church staff with an earthquake simulation prior to the ShakeOut to motivate preparedness.
- John White reported that those who use St. John Neumann facilities will be provide emergency information and staff members will be provided with an emergency kit for their cars in preparation for ShakeOut.
- Jim Russell spoke about Operation Christmas Child through Samaritan's Purse. Call 714-432-7030 for information related to Orange County opportunities.
- Lee Sandusky spoke about the role of ham (amateur) radio operators in emergency situations and encouraged partners to take classes if interested. He will notify Vicki of upcoming classes to be posted to the website.
